## Direction

No.1 of 2019

### **Specified hearings for participation by a detained person through live television link**

*This Direction replaces Direction No.1 of 2018 and takes effect from 7 March 2019.*

Under and by virtue of the power conferred on me by section 288K of the Criminal Procedure (Scotland) Act 1995, I hereby specify that a detained person may participate through live television link in the following types of hearings:

1. An appeal hearing in the High Court of Justiciary sitting in Edinburgh or Glasgow in respect of which the detained person is a prisoner in one of the places of detention specified in Schedule A to this direction.
2. A preliminary hearing in the High Court of Justiciary sitting in Edinburgh or Glasgow in respect of which the detained person is a prisoner in one of the places of detention specified in Schedule A to this direction.
3. An appeal hearing in the Sheriff Appeal Court sitting in Edinburgh or Glasgow in respect of which the detained person is a prisoner in one of the places of detention specified in the Schedule A to this direction.
4. A full committal, an intermediate diet or a sentencing hearing in any of the Sheriff Courts specified in Schedule B to this direction, but only if the detained person is a prisoner in one of the places of detention specified in schedule A to this direction.
