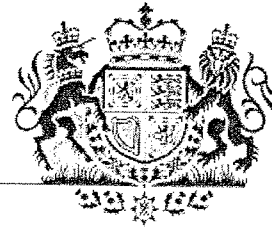


# Sheriffdom of North Strathclyde



## Refixing Diets upon the Death of Her Majesty, Queen Elizabeth II in respect of Summary Criminal Business in Dumbarton and Oban Sheriff Courts

### Order No 5 of 2022

Diets assigned to call on 19 September 2022 in Dumbarton and Oban Sheriff Courts are no longer suitable to the court.

In accordance with the powers set out in section 137ZB of the Criminal Procedure (Scotland) Act 1995 ("the 1995 Act"), the court of its own accord hereby:


- (a) discharges all trial diets which had been assigned to call in Dumbarton Sheriff Court on 19 September 2022, in respect of summary criminal proceedings with the procurator fiscal reference number referred to in Column B of Schedule 1 to this Order involving the accused named in the same row in Column A and fixes a new trial diet in each of the proceedings for the date specified in Column C.
- (b) discharges all intermediate diets which had been assigned to call in Dumbarton Sheriff Court on 19 September 2022, in respect of summary criminal proceedings with the procurator fiscal reference number referred to in Column B of Schedule 2 to this Order involving the accused named in the same row in Column A and fixes a new ~~trial~~ <sup>intermediate</sup> diet in each of the proceedings for the date specified in Column C.
- (c) discharges all deferred sentences which had been assigned to call in Dumbarton Sheriff Court on 19 September 2022, in respect of summary criminal proceedings with the procurator fiscal reference number referred to in Column B of Schedule 3 to this Order involving the accused named in the same row in Column A and fixes a new ~~trial~~ <sup>deferred sentence</sup> diet in each of the proceedings for the date specified in Column C.

- (d) discharges all trial diets which had been assigned to call in Oban Sheriff Court on 19 September 2022, in respect of summary criminal proceedings with the procurator fiscal reference number referred to in Column B of Schedule 4 to this Order involving the accused named in the same row in Column A and fixes a new trial diet in each of the proceedings for the date specified in Column C.
- (e) discharges all deferred sentences which had been assigned to call in Oban Sheriff Court on 19 September 2022, in respect of summary criminal proceedings with the procurator fiscal reference number referred to in Column B of Schedule 5 to this Order involving the accused named in the same row in Column A and fixes a new ~~trial~~ <sup>deferred sentence</sup> diet in each of the proceedings for the date specified in Column C.

In respect of all cases in which an accused person has a deferred sentence calling in the same court and on the same date as a diet which has, by virtue of this Order been discharged, a new diet of deferred sentence will be fixed for the same day as the new diet assigned by virtue of this Order.

The Sheriff Clerk is appointed to intimate said new diets to parties.
