Order Refixing Diets: No 3 of 2025

in respect of Summary Sheriff and Justice of the Peace Courts Criminal Business in Ayr Sheriff Court

Due to exceptional circumstances which could not reasonably have been foreseen, it is not practicable for Ayr to proceed with all of the summary criminal cases due to call in relation to Sheriff and JP business on 24 January 2025.

This Order is made pursuant to the powers vested in me in terms of Section 137ZB of the Criminal Procedure (Scotland) Act 1995.

I hereby Order that:

In accordance with the power set out in section 137ZB of the Criminal Procedure (Scotland) Act 1995, the court of its own accord, hereby discharges the diets listed in the attached Schedule to this order, due to call at Ayr Sheriff and Justice of the Peace Courts on 24 January 2025, which is no longer a date suitable to the court and refixes to a new date listed in column C of the schedule.

In respect of all cases in which an accused person has a deferred sentence calling in the same court and on the same date as a trial diet which has been discharged by virtue of this Order, a new diet of deferred sentence will be fixed for the same day as the new trial diet as the case may be.

The Sheriff Clerk is appointed to intimate said new diets to parties.
