SCOTTISH PARLIAMENTARY QUESTION S4W-10705, S4W-10707, S4W-10708, S4W-10711, S4W-10713, S4W-10714, S4W-10716, S4W-10717

The Cabinet Secretary in his response to the above PQ indicated that it relates to operational matters within the responsibility of the Scottish Court Service corporate body. I am now writing to you in response to the matter you have raised.

**S4W-10717** asks how many solemn criminal trials are expected to be transferred from Aberdeen Sheriff Court to Stonehaven Sheriff Court in 2013.

The Sheriff Principal has set in place a recovery plan to tackle a backlog in solemn business at Aberdeen that will see the number of Sheriff and Jury Sittings programmed at Stonehaven during 2013 increase from 4 to 12. The number of cases assigned to each Sheriff and Jury sitting will be capped at 5 and will include business originating in Stonehaven. It is estimated that approximately 40 solemn criminal trials that would normally call in Aberdeen will call in Stonehaven during 2013.
