SCOTTISH PARLIAMENTARY QUESTION S5W-14774

The Cabinet Secretary in his response to the above PQ indicated that it relates to operational matters within the responsibility of the Scottish Courts and Tribunals Service corporate body. I am now writing to you in response to the matter you have raised.

S5W-14774 asks: how many criminal trials in each of the last 10 years have been abandoned with the presumption that they could be heard at a later date (deserted pro loco et tempore), and how many were subsequently held later, also expressed as a percentage.
