SCOTTISH PARLIAMENTARY QUESTION S6W-32320 & S6W-32321

The Cabinet Secretary in her response to the above PQ indicated that it related to operational matters within the responsibility of the Scottish Courts and Tribunals Service corporate body. I am now writing in response to the matter raised.

S6W-32320 asks: how many court sittings were cancelled due to a lack of resources at Aberdeen courts in each of the last five years?

Trials may be adjourned on defence or Crown motion. Trials may also be adjourned on the motion of the court.

With the exception of court adjournments due to 'lack of court time', it is not possible to identify which individual trials were adjourned due to a particular resource issue without interrogating individual court minutes.

SCTS takes the efficiency of court programming seriously. Typically, more than one trial is scheduled for each court sitting. This is to ensure that there is sufficient business for the court to consider that day should a trial resolve early by way of a plea, or be adjourned on Crown or defence motion. This is a balanced approach which provides flexibility to maximise the efficient use of court time.

Some trials will inevitably last longer than others due the inherent complexities in criminal procedure. On some occasions, this means a small number of trials will be adjourned due to a lack of court time.

Trials that are adjourned due to a lack of court time are continued to the next available sitting day.

The average percentage of trials adjourned in Aberdeen in 2024/25 to date, due to lack of court time, is 1.6%. There have been no High Court trials calling in Aberdeen adjourned due to lack of court time in 2024/25 to date.

S6W-32321 asks: how many cases were handled by Aberdeen courts in each of the last five years, broken down by court type?

Please see below table of Cases registered at Aberdeen:

Petitions are not included in the total count of cases registered as not all petitions lead to further criminal proceedings. Any petition in which there are further proceedings will go on to become registered as a complaint or indictment. Therefore petition numbers have been excluded from the total to remove any element of 'double counting'. High Court indictments are registered centrally rather than by specific court location.

SCTS publishes a range of data on criminal business on our website at <u>Publications</u> <u>Scottish Courts</u>. The Monthly Criminal Management Information (MCMI) report contains extensive data in relation to the throughput of criminal business, including trial adjournments. The MCMI provides data from 2019-20 and is updated monthly.
